- The work relating to Administration & Establishment of Central GST & Central Excise Pathanamthitta Divn will be assigned to Administration section of Central GST & Central Excise Kollam Divn.
- The work relating to Administration & Establishment of Central GST & Central Excise Alappuzha Division will be assigned to Administration section of Central GST & Central Excise Kottayam Division.

Leave in respect of the officers posted in individual Central GST & Central Excise Divisions would be sanctioned by the respective Deputy/Assistant Commissioners of the individual Central GST & Central Excise Divisions.

The Asst. Commissioner, Central GST & Central Excise Kollam Division is hereby directed also to designate one officer in the cadre of Superintendent as Administrative Officer for Kollam Divn.
