Terms & Conditions

- 1) The sale will be effected through invitation of quotations. A public auction will be conducted only if the sealed quotations do not fetch the Reserve Price of the goods fixed by the competent authority. Interested parties for purchasing the goods on **"as is where is"** condition, can submit sealed

- Quotations and participate in the public auction in the event of the same being carried out by the department.
- 2) The bidders are to produce Electoral Card, Aadhar card Passport or Driving License as a proof of identity.
 - 3) Sealed Quotations superscripting **“Quotation for purchase of old, obsolete and unserviceable goods”** are to be submitted to the Superintendent (PRO) on or before **14.00 Hrs of 26.12.2018**. Sealed quotations are to contain the item wise bid amount and correct address of the bidder. The sealed quotations submitted by the bidders will be opened on **26.12.2018, at 16.00 Hrs** at the Conference Hall of Central GST & Central Excise Commissionerate, GST Bhavan, Press Club Road, Statue, Thiruvananthapuram 695001. Bidders who wish to be present at the time of opening of quotations may do so and no further intimations in this regard will be issued from this office unless otherwise required due to change in date and time of opening of quotations.
 - 4) Sale will be effected to the person who offer the highest amount (H1) in sealed quotation or during auction.
 - 5) The goods will be sold on the assumption that bidders have inspected the goods and know what they are buying irrespective of the fact whether they have actually inspected the goods or not. This office does not give any guarantee/ warrantee or undertake any responsibility for the make, manufacture, Description, quality, condition, size, weight, grade, accuracy or whatsoever of the goods.
 - 6) No sale can be invalidated by reasons of any defect or fault in the goods or fault in the description/terminology in the NIQ.
 - 7) All the tax liabilities whether state or central Levy, on the purchase of the goods are to be met by the purchaser.
 - 8) The successful bidder after completion of Quotation/Auction process shall pay the quoted amount and applicable taxes if any, to the Government account and take delivery of the goods on submission of proof of remittance - on or before 31.12.2018, Monday. In the event of delay on the part of the highest bidder to remove the goods from this office premises

If upon finalization of bid proceedings, the successful bidder fails to pay the required money, within the stipulated time mentioned in the NIQ, the listed goods will then be offered to the next highest bidder provided the price quoted by H2 fetch the reserve price fixed by the competent authority.
