Terms and conditions:-

- i) The financial offer should be inclusive of all taxes, duties, GST and any such statutory levies applicable and no additional payment whatsoever shall be made to the bidder over and above the quoted rate.
- ii) The offers shall be submitted along with a copy of bid document duly signed by the bidder or his authorized representative as a token of acceptance of the terms and conditions in this bid document.
- iii) Bidders are requested to inspect each and every AC's covered under this work thoroughly and offer their quote including servicing of the same.
- iv) The successful bidder shall start the repair work immediately after issue of work order. It would be desirable to carry out the work on Saturday and Sunday so that the office work is least affected.
- v) Bidder shall make his own arrangements for the safety of his workers, staff working at GST Bhavan while undertaking the repair work and this office will not be responsible for any accident/ mishap.
- vi) Bidder shall use ISI marked/ standard company parts of first quality for replacement if any. Any new parts which are being replaced against the existing ones need to be approved by the PRO, CGST & Central Excise.
- vii) Any part required for replacement shall have to be of same make/ capacity.
- viii) The bidder should provide warranty of 12 months for the repaired AC from the date of repair.
- ix) Any breakdown call reported by this office with respect to the repaired AC's need to be attended within two days during the warranty period for which
