Terms & Conditions

- 1) The sale will be effected on the basis of inviting sealed quotations. A public auction will be conducted only if the sealed quotations do not fetch the Reserve Price of the Vehicle fixed by the competent authority. Persons interested in purchasing the vehicle on "as is where is" condition, can submit sealed Quotations and participate in the public auction.
- 2) The bidders are required to produce Electoral Card, Aadhar card, Passport or Driving License as a proof of identity.
- 3) Sealed Quotations superscribed "**Quotation for purchase of Vehicle**" are to be submitted to the Superintendent, PRO on or before 11.00 Hrs on 31.10.2018. Sealed quotations are to contain the bid amount and correct address of the bidder. The sealed quotations will be opened on 31.10.2018, at 14.00 Hrs at the office room of the Assistant Commissioner of Customs, Room No.702, Customs Preventive Division, 6th Floor, GST Bhavan, Press Club Road, Statue, Thiruvananthapuram 695001.
- 4) The bidders have to deposit Earnest Money Deposit of **Rs. 5,000/-** (Rupees Five Thousand Only) by way of Demand Draft Drawn from any of the nationalized banks in favour of "**Commissioner of Customs, Customs Preventive Commissionerate, Kochi**" along with the Quotations. The said amount in respect of the successful bidder will only be retained in lieu of advance sale price and the same will be adjusted from the final bid price. The EMD of unsuccessful bidders will be returned immediately after the auction proceedings.
- 5) Sale will be effected to the person who quotes the highest amount in sealed quotation.

- 6) The goods will be sold on the assumption that bidders have inspected the vehicle and know what they are buying, irrespective of the fact whether they have actually inspected the goods. The department does not give any guarantee or warrantee or undertake any responsibility for the make, manufacture, Description, quality, condition, size, weight, grade, accuracy or whatsoever of the Vehicle.
- 7) No sale can be invalidated by reasons of any defect or fault in the goods or fault in the description/terminology in the Auction Notice.
- 8) All the tax liabilities whether state or central Levy, on the purchase of the vehicle & defaulted liabilities if any are to be met by the purchaser.
- 9) The successful bidder on 31.10.2018 after completion of bid evaluation process shall pay the full amount and the applicable taxes and take delivery of the goods or pay 25% of the bid amount (in cash – excluding the EMD of Rs.5,000/-) and take delivery of the goods subsequently – on or before 01.12.2018, Thursday, after payment of the entire bid amount and the applicable taxes. If the successful bidder on quotation is not present at the closure of the auction proceedings, 25% of the bid amount will be collected from the next highest bidder. In the event of delay on the part of the highest bidder to remove the vehicles from the premises of this office, the office will not be responsible for any deterioration or destruction sustained to the said vehicle. If on the completion of auction, the successful bidder fails to pay the required money, the security deposit will be forfeited. The vehicle will then be offered to the next highest bidder or re-auction may be conducted at the discretion of the Assistant Commissioner of Customs, Customs Preventive Division, Thiruvananthapuram.
- 10) Successful bidder shall ensure to register the vehicle possessed through bidding in his own name or any other person authorized by the successful bidder within 15 days of completion of auction.
- 11) The bidders are directed to give their correct names and detailed postal address. Name once given at the time of paying the EMD cannot

be changed in the bid sheet. The delivery order and ownership of the vehicle will be issued in the name given in the bid sheet only and be received by the person who signed the bid sheet at the time of auction.

- 12) Assistant Commissioner of Customs, Customs Preventive Division, Thiruvananthapuram reserves the right to reject any bid finally accepted in the Auction proceedings or cancel the Auction proceedings as such without assigning any reasons whether or not the bidder has paid the full amount.
